

Placement to Sophisticated Investors

FYI Resources Limited (ASX:FYI) is pleased to announce that a small scale capital raising, arranged through Peloton Capital to sophisticated investors, has been successfully completed.

The capital raising is intended for working capital to allow FYI to further its due diligence on selected project reviews and also to continue exploration on its current asset base being the Yarlalweelor Uranium Project in Western Australia.

Details of the raising

FYI has issued 6.91 million fully paid shares at \$0.045 per share, raising \$310,000 under ASX listing rule 7.1. The raising was subscribed to by sophisticated investors.

The new shares issued are part of a class of security quoted on the ASX Limited. The Company gives this notice pursuant to Section 708A(5)(e) of the Corporations Act.
