

FYI Finalises Placement

FYI Resources Limited (ASX: FYI) advises that it has raised \$200,000 through the issue of 6,666,668 fully paid ordinary shares at an issue price of \$0.03 per share to sophisticated investors. The Placement was managed by Sydney based Peloton Capital Pty Ltd.

The proceeds of the issue will be used to advance the Company's Southeast Asian potash strategy and for working capital purposes.
